Pre-entries: \$15.00 per dog (please include \$2 for FTE). Pre-entries close Friday, March 30 at 9:00 pm. Pre-entries may be made by phone, e-mail, or snail mail to the Race Secretary listed below.

Same-day entries: \$18 per dog (plus \$2 for FTE). Entries close 12:15 pm on Saturday, March 31 at the Race Secretary's table located on the show grounds where conformation is held.

Race meets will be 3 program, 4 dog races, 200-yard straight sprints. NOTE: All dogs will be hand slipped.

All dogs must run with muzzles and racing blankets. A small number of muzzles and blankets will be available for loan.

**ELIGIBILITY**

Hounds must be one year of age or older to be eligible and must not be lame, sick, or in season.

Each hound must be individually registered with the American Kennel Club (AKC), Canadian Kennel Club (CKC), or the United Kennel Club (UKC). Hounds registered with the AKC under Indefinite Listing Privilege (ILP) or the CKC equivalent may also be entered.

Each hound must have a completed and signed entry form. Those with First Time Entered (FTE) hounds must attach a photocopy of your dog's registration to your entry form, along with a one-time \$2.00 registration fee.
