DIRECTIONS TO THE SPECIALTY

Driving: From Philadelphia & Points East & West – Follow the PA Turnpike West to Exit 298 (old Exit 22). After tollbooth follow signs for the **HQ Hotel**, take Exit 1B (Morgantown). Continue for ½-mile, hotel is on the right; for **showgrounds**, take Exit 1A, go North 4-12 miles on Rt. 10 (Morgantown Rd./Reading Rd.) to showgrounds on left, just past Chestnut Hill Rd.
From the North: - South on 81 to Rt. 61 South. Take 61 South to 222 South. Follow 222 S to 422 East. Take 422 East to Rt.176 South. Follow Rt.176 South to Exit 1. At stop sign, for **hotel** turn right & travel ½-mile to hotel on the right, for **showgrounds** turn left & go 4-1/2 miles to grounds on left.
From the South: - Route 83 North to PA Turnpike. Turnpike East to Exit 298 (old Exit 22). & follow directions above “After toll booth” for driving from East & West.

SATURDAY- Puppy Practice Match – A very low-key event to be held in the Sweepstakes format. Classes offered for both sexes: 6-9, 9-12, 12-15, & 15-18. – \$10 per entry. Best in Match and Best of Opposite in Match, Judge to be announced. Entries will be taken at 2:00 PM – Judging will start at 3:00 PM.

SUNDAY - CARDIAC TESTING - IWF LIFE CYCLE CARDIAC STUDY & OFA CERT

The **Irish Wolfhound Foundation** is sponsoring heart screening with on-site cardiologist on **Sunday**, October 9, 2022. A contribution of \$175 per hound (\$100 for hounds over 8 years old) for echocardiogram with electrocardiogram (EKG) or \$60 for auscultation and EKG is suggested. The balance of the cost is covered by the IWF. Entry is limited and preregistration is advised. This clinic is for screening and research only. Dogs requiring treatment will be referred to your local cardiologist.
